## **BUILDING DESCRIPTION**

The hotel is located at the corner of 45<sup>th</sup> Street and Broadway. The hotel is comprised of one building:

Floors 3-7 – meeting space

Floor 8 – lobby and restaurants

Floor 9 - meeting space

Floors 10-45 – Guestrooms

Floor 47 – View Restaurant

The main entrance is at 1535 Broadway.

The loading dock is accessed from 45<sup>th</sup> St. between Broadway and 8 Ave. The building is 51 stories including 2 levels below street level.

The building is a type 1 construction consisting of concrete and steel. The hotel has a total of 1.825 million square feet floor space and is fully

covered by sprinkler system.

The building was commissioned September 1985.

## BUILDING LIFE SAFETY FEATURES

Fire Alarm System is an Auto Call TFX-800 combined with a Honeywell FS-90 Fan interface for smoke evacuation control and a Public Address System through the entire building.

One (1) automatic 1000 GPM serves the B level to the 26<sup>th</sup> floor All are electric pumps: One 7500 GPM manual fire pump serves the entire building; One 500 GPM automatic serves 27<sup>th</sup> floor to the 50<sup>th</sup> floor; One 5000 gallon gravity tank ocate4d on the 50<sup>th</sup> floor.

# FIRE SAFETY

The New York Marriott Marquis Hotel has been engineered to meet and exceed fire codes.

For your safety, in case of fire, please read this information carefully. Pay special attention

to the smoke safety instructions since smoke inhalation causes more fatalities that the fire

itself. Make sure everyone in your family or business meeting reads it as well. If you have

any questions, please feel free to contact Engineering Department at 8939.

### WHEN YOU CHECK INTO YOUR GUESTROOM

Locate the nearest fire exit and fire extinguisher

Examine the staircase layout.

Count the doors between yours and the nearest fire exit – REMEMBER HOW MANY THERE ARE.

The building has 4 stairwells marked A, B, C, & D and all have access to the street.

### IF THERE IS A FIRE

Call the in-house emergency number, touch 0.

Pull the fire alarm pull station IF THERE IS ONE NEARBY.

REMAIN CALM. You will be much safer if you are thinking clearly rather than panicking.

LEAVE IMMEDIATELY IF THERE IS A FIRE IN YOUR ROOM,

AND CLOSE THE DOOR SECURELY BEHIND YOU.

Crawl to the door if the room is smokey. AIR IS FRESHER NEAR THE FLOOR.

Feel the door before leaving your room. IF IT IS HOT, DO NOT OPEN IT. If it is cool, open your door slowly, just enough to check the hallway. BE READY TO CLOSE THE DOOR SECURELY

IN CASE OF HEAVY SMOKE IN THE HALLWAY

## IF YOU LEAVE YOUR GUESTROOM

Take your room key with you. Keep a wet cloth over your nose and mouth. Close the door behind you.

Crawl to the nearest fire exit, STAYING NEAR THE WALL. Even if you do not see smoke, toxic fumes can be invisible and air is always fresher near the floor.

Remember the number of doors to the nearest fire exit and count them as lights may be off or may go off during a fire.

DO NOT USE ELEVATORS. USE STAIRWELL ONLY.

RETURN TO YOUR ROOM IF STAIRWELL IS SMOKE-FILLED.

If stairwell is clear, proceed downstairs holding the handrail.

## IF YOU HAVE TO STAY IN YOUR GUESTROOM

Wet cloth and tie it over your nose and mouth in a triangle for easier breathing

Fill the bathtub and sink with water

Seal your room by wetting towels, sheets, etc., and placing them around the cracks in the door and the window IF THE FIRE IS OUTSIDE.

Turn off the air conditioner.

Open the window if there is no smoke outside. DO NOT BREAK THE GLASS UNLESS

NECESSARY AS YOU MAY NEED TO CLOSE IT LATER.

Throw water onto hot surfaces (walls, doors, etc.) using a trash can, ice bucket, etc.

Wave a wet towel in the room to clear possible smoke.

Signal for help. If the telephone works, use it or hang a bed sheet out of the window or flash lighting.

### REMEMBER

- 1. Be prepared by understanding the above information.
- 2. Pre-planning always helps in a stressful situation.

## EMERGENCY COMMUNICATION

### **REPORTING A FIRE**

Pull a manual fire alarm station located at each stairwell. Use the telephone and dial the HOTEL OPERATOR "O" Use the telephone and dial the EMERGENCY HOT LINE extension "6666". Use the telephone and dial "9-911"

#### FIRE ALARM SYSTEM

The fire alarm system consists of both visual (strobes) and audio (whopping sound) devices.

When an alarm is activated from any source, a signal is sent to the FIRE COMMAND ROOM (FCC), PBX, LOSS PREVENTION DISPATCH, ENGINEERING EMS., AND OUR HOTEL MONITORING COMPANY (ADT) at the same time, the strobes and sirens are activated on the floor of the alarm. Also, the magnetic door holders are released and the smoke control system is activated accordingly. If an elevator smoke detector is activated the elevators will be recalled to the 1st floor.

#### PUBLIC ADDRESS SYSTEM

The fire alarm system includes a public address system. The controls and microphone are located in FCC. There are speakers located in every guestroom and throughout the entire hotel. Announcements can be made to individual floors, multiple floors, or the entire hotel.

In response to the various conditions which occur during an emergency, the following scripts are provided to communicate with hotel guests and staff over the public address system in case of a fire alarm.

NOTE: Read the text slowly and clearly. Repeat the announcement two times.

INITIAL ANNOUNCEMENT OF AN ALRAM CONDITION:

Your attention please. Your attention please. This is the Fire Safety Director. There has been an alarm detected on your floor. Please stand by and remain calm. We are investigating at this time and will make further announcements. Thank you.

#### ANNOUNCEMENT TO CANCEL AN ALRAM CONDITION

Your attention please. Your attention please. This is the Fire Safety Director. We have investigated the alarm, on your floor. No further action is required on your part. Thank you.

### ANNOUNCEMENT TO EVACUATE THE BUILDING

Your attention please. Your attention please. This is the Fire Safety Director. A fire incident is occurring at the hotel. Please evacuate the building. Do not use the elevators. Walk calmly to the nearest stairwell exit and leave the building. Please follow the directions of the Emergency Response Team. Dial "0" on you phone if you require assistance. Remember to remain calm.
